# **Agenda Items Discussed**

### 1. Welcome Address

- o Dr. R G Sharma, President, ICC, welcomed all the members of the new EC.
- He expressed his happiness that the first EC meeting was being held when one of ICC's distinguished Fellows, Dr. V. Narayanan, Head LPSC has risen to the position of the ISRO Chief and the Secretary Deptt. Of Space, GOI.
- He also expressed gratitude to all the past Presidents of ICC for their exemplary contributions to the organization's growth.

# 2. ICC Website Updates

o It was observed that the ICC website has not been updated for a long time It should therefore be updated on a priority basis. Henceforth, the website should be updated periodically say once a month.

# Implementation & Coordination:

 Dr. Soumen Kar and Dr. Anuj Kumar will coordinate with the person responsible for the maintenance of the website. The inputs to website may be routed through the secretary ICC.

## Website Overhaul:

• The president will form a team of 2-3 persons who will work together on a comprehensive overhaul of the website to make it more effective.

## 3. New Memberships

- Efforts by Dr. Abhilash Narayan (LPSC, ISRO), and Dr. Hari Kishan (Ex NPL) & Dr. Anuj Kumar (JIIT) have led to a significant increase in the new memberships.
  ICC welcomes the new member to its fold.
- o Membership certificates will be issued soon.
- o It was also emphasized by the members that while admitting new members we must follow the eligibility criterion set by the ICC.

### 4. Consolidated List of ICC Members

 The EC appreciated Dr. Anuj Kumar's efforts in preparing a consolidated list of ICC members.in alphabetic order. More refinement will be done in due course.

## 5. ICC Golden Jubilee Celebrations (2025)

- The year 2025 marks the Golden Jubilee of the ICC.
- o The EC has decided to organize a two-day conference preferably at Kolkata, the birth place of the ICC. VECC was considered the obvious choice. The other alternative discussed was the CSIR-NPL New Delhi. Dr. R G Sharma indicated that

he once apprised the present NPL director about the history of ICC vis-à-vis NPL's contribution to its growth and the distinction of holding quite a number of ICC Symposia at NPL. Dr. Sharma was requested to explore the possibility of holding the conference at NPL.

 Prof. Datta clarified that the conference will be an ICC affair and would be organized in collaboration with the hosting institute as per the ICC norms.

## Next Steps:

- o It was decided to form an Advisory Committee to work out all the details like the venue, time duration, financial requirements, and other modalities of the conference. The committee members will be: Dr. R G Sharma (Chair), Prof. MD Atrey, Prof. TS Datta, Prof. SC Sarkar, Dr. Uttam Bhunia and Dr. Soumen Kar. Before fixing the dates, the committee would coordinate with the host institute about the availability of the infrastructural and related facilities such that our conference does not clash with their calendar.
- o The president will then send a formal request letter to the head of the institution selected as the venue.

# 6. NCCS-30 Venue

 A formal letter will also be sent by the president ICC to the Director, LPSC, requesting him to host NCCS 30.

### 7. Reconstitution of Zonal Committees

- The EC also decided to form adhoc Zonal committees in respect of North, South and East where periodic regular elections have not been held for quite some time The EC authorized the president to form adhoc zonal committees for the north, East and south zones where regular elections have not been held for some years. The adhoc committees will conduct regular elections as per the well laid ICC procedure within 10 months.

- Dr. R G Sharma suggested the formation of a 3-member committee with Prof. R Singh, Dr. Mukesh Goel and Prof. TS Datta

 Prof. TS Datta reported that the pending IJC Volume 48 will be published soon.

### 9. Permanent Secretariat

- Proposal for Location:
  - The need for a permanent secretariat of ICC have been felt by the members for many years. Prof. S. C. Sarkar was requested to provide a room for the ICC office at Salt Lake City Campus.
  - After enough discussion, Prof. Sarangi suggested that Cryogenic Engineering Centre at IIT Kharagpur would be a more suitable location due to:
    - Presence of the permanent faculty members at the Cryogenic
    - Engineering Centre and good number of ICC & EC members.
    - Students' involvement.
    - Established infrastructure.
    - Decision to form ICC was taken at this place in 1975

### • Next Steps:

 Prof. Sunil Sarangi will draft a formal letter for the president ICC addressed to the Director, IIT Kharagpur, with a copy to the Head of the Cryogenic Engineering Centre. The president will then write a formal letter to the Director IIT Kharagpur.
